Extracts from Constitution of the Federation

1. OBJECTIVES

To promote manufacturing, marketing, sourcing, merchandising and distribution of all textile, apparel and fashion related businesses. To represent and safeguard the interests of these industry players.

2. FEDERATION'S STRUCTURE

The Federation comprises 3 Groups made up as follows:

- Group I Manufacturers & Traders & Buying Agencies
- Group II Designers & Retailers
- Group IIIa Associate Member - Support
- Group IIIb Associate Member - Academic

3. MEMBERSHIP

I. Group I – Members (Manufacturers & Traders & Buying Agencies)

Any Company carrying on business in the textile, yarn or apparel industry in the Republic of Singapore shall be eligible as a member.

Any Company providing designing services or engaging in the trading or buying house services, offering consultancy or other related services to the fashion industry in the Republic of Singapore, shall, at the discretion of the Management Committee, be eligible as a member.

II. Group II – Members (Designers & Retailers)

Any Company carrying out business or services in the fashion lifestyle design and/or retail business in the Republic of Singapore shall be eligible as a member.

Any person, providing or engaging in the services of designing or merchandising in the fashion industry in the Republic of Singapore shall be eligible as a Member.

III. Group III (a) – Associate Members (Support)

Any Company providing services or support to the fashion Industry shall, at the discretion of the Management Committee, be eligible as an Associate member (Supporting Industries).

Any non-Singapore Registered Company carrying on business in the fashion industry, or providing designing services or engaging in the trading or agencies, or offering consultancy or other related services to the fashion industry, shall, at the discretion of the Management Committee, be eligible as Associate Member (Support).

Group III (b) – Associate Members (Academic)

Any person, studying or teaching or engaging in research work at academies of arts or fashion in related fields of fashion designing or services in the Republic of Singapore, shall, at the discretion of the Management Committee, be eligible as Associate member (Academic).

4. ADMISSION

Any applicant for membership shall fill up an application form, which will be lodged at the Management Committee meeting for approval. After the application has been passed by the Management Committee Meeting and after payment of the Entrance Fee and Subscription shall be a member/associate member.

5. ENTRANCE FEE & SUBSCRIPTION

The entrance fee and monthly subscription shall be such sums as the members in general meeting may from time to time prescribe, but until otherwise prescribed, the entrance fee and monthly subscriptions will be as follows:
