MEMBERSHIP CATEGORIES & FEE STRUCTURE

GROUP 1: MANUFACTURERS

Any company which is a manufacturer and/or trader that carries business in the textile, yarn or apparel industry; provides designing services; engages in the trading or buying house services, offers consultancy or other related services to the fashion industry in Singapore.

GROUP 2: DESIGNERS & RETAILERS

Any company who is a designer/retailer that carries business or provides services in fashion lifestyle, design and/or retail business; provides or engages in the services of designing or merchandising in the fashion industry of Singapore

GROUP 3: ASSOCIATE MEMBERS

3a: Any person who provides services or support to the fashion industry; any company which is not eligible to be in Group 1 or 2 but provides services or support to the fashion industry; foreign company who carries business or offers any consultancy and/or any other related services to any fashion industry in the world

3b: Any academic person (students)
