Any company providing designing services or engaging in the trading or buying house services, offering consultancy or other related services to the fashion industry in the Republic of Singapore, shall, at the discretion of the Management Committee, be eligible as Member.	Yes
2a	Any company carrying out business or services in the fashion lifestyle design and/or retail business in the Republic of Singapore shall be eligible as a member. Any person, providing or engaging in the services of designing or merchandising in the fashion industry in the Republic of Singapore shall be eligible as Member.	Yes
2b	Any company carrying out business or services in the fashion footwear and accessories design and/or retail business in the Republic of Singapore shall be eligible as Member.	Yes
3a	Any company providing services or support to the fashion Industry shall, at the discretion of the Management Committee, be eligible as Associate Member (Supporting Industries). Any non-Singapore registered company carrying on business in the fashion industry, or providing designing services or engaging in the trading or agencies, or offering consultancy or other related services to the fashion industry, shall, at the discretion of the Management Committee, be eligible as Associate Member (Support).	No
3b	Any person, studying or teaching or engaging in research work at academies of arts or fashion in related fields of fashion designing or services in the Republic of Singapore, shall, at the discretion of the Management Committee, be eligible as Associate member (Academic).	No
